Ingredients

Aqua (water), sodium laureth sulfate, cocamidopropyl betaine, sodium C12-18 alkyl sulfate, coco glucoside, glyceril oleate, glycerin, Benzyl alcohol, Glyceryl Laurate, citric acid, parfum (fragrance), CI 42090, CI 19140.

Conservation instructions
