<b>Section 4. First-aid measures</b>	
<b>Inhalation</b>	IF INHALED: Remove person to fresh air and keep comfortable for breathing. Call a doctor if you feel unwell.
<b>Ingestion</b>	IF SWALLOWED: Immediately call a doctor. DO NOT INDUCE VOMITING. NEVER give anything by mouth if victim is rapidly losing consciousness, or is unconscious or convulsing. Rinse mouth thoroughly with water. Have victim drink two glasses of water. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration.

<b>Personal precautions, protective equipment and emergency procedures</b>

<b>Methods and materials for containment and cleaning up</b>	
Avoid release to the environment. Collect spillage. Ventilate area of release. Stop the leak if it can be done safely. Contain and absorb any spilled liquid concentrate with inert absorbent material, then place material into a container for later disposal (see Section 13). <b>Precautions for safe handling</b>	
Protect from sunlight. Do not expose to temperatures exceeding 50 °C/122 °F. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Use only outdoors or in a well-ventilated area. Wash hands/nails/face thoroughly after handling. Wear gloves/protective clothing/eye protection/face protection. Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Inspect containers for leaks before handling. Label containers appropriately. Ensure proper ventilation. Avoid breathing dust/fume/gas/mist/vapours/spray. Avoid contact with eyes, skin and clothing. Keep away from heat, sparks and flame.
